The undersigned further expressly agrees that the forgoing waiver and assumption of risk agreement is intended to be as brad and inclusive as is permitted by the law of the State of Illinois and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
